



The All Cap Value Equity Composite has been examined for the periods from May 1, 2001 through December 31, 2018. The examination reports are available upon request.

The Cooke & Bieler All Cap Value Equity Composite (Composite) currently includes all fully discretionary, fee paying and non-fee paying all cap value equity portfolios managed for more than one month. During 2012, the minimum market value for inclusion was \$1 million. Prior to 2012, the minimum market value for inclusion was \$2,500. For investment purposes, we generally define all cap equity securities as those of companies whose market capitalization is greater than \$1,51 billion and within the range of the Russell 3000® ledax of initial time of purchase. The Composite was created in May 2001. All Cap portfolio holdings are chosen from securities held in the firm's large, mid and small cap portfolios. The investment team regularly reviews these portfolios to determine which securities are to be held in the All Cap portfolio. Typically, those stocks that have higher portfolio weights in the large, mid and small cap portfolios represent a substantial portion of the All Cap portfolio securities.

Rates of return are expressed in U.S. dollars. Portfolios are valued monthly on a trade date basis. Portfolio returns reflect the reinvestment of dividend and interest income and are calculated using the Modified Dietz method. The standard fee agreement currently in effect is 0.75 of 1% per annum on the first \$20 million of principal, 0.65 of 1% per annum on the next \$20 million of principal and 0.55 of 1% per annum on the next \$20 million of principal and 0.55 of 1% per annum on the next \$20 million of principal and 0.55 of 1% per annum on the remaining balance, however fees are negotiable. For comparison purposes, the Composite is measured against the Russell 3000@ Value Index. The Russell 3000@Value Index measures the performance of those Russell 3000@ companies with lower price-to-book ratios and lower forecasted growth values. The Russell 3000@ Value Index returns are provided to represent the investment environment existing during the time periods shown and are not covered by the report of independent verifiers. The dispersion is measured using an asset weighted standard deviation of portfolio returns represented within the Composite for the full year. A list of composite descriptions is available upon request. Policies for valuing portfolios, calculating performance, and preparing compliant presentations are also available upon request.

The three-year annualized ex-post standard deviation measures the variability of the composite (using gross returns) and the benchmark for the preceding 36-month period. The three-year annualized ex-post standard deviation is not required to be presented for periods prior to 2011 or when 36 monthly composite returns are not available.
